


1. The above recitals are true and correct and are incorporated fully herein by reference.



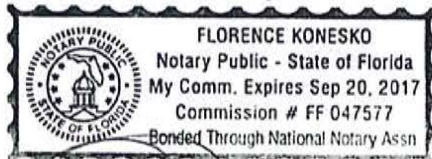
