WHEREAS, the Board of Fire Commissioners for the **Southern Manatee Fire & Rescue District** of Manatee County, Florida, on September 7, 2016, conducted a duly noticed public hearing to consider the adoption of a tentative budget for Fiscal Year 2016 – 2017, as required by Section 200.065, Florida Statutes; and

WHEREAS, the Board of Fire Commissioners for the **Southern Manatee Fire & Rescue District** of Manatee County, Florida, set forth the appropriations and revenue estimate for the tentative budget for Fiscal Year 2016 - 2017 in the amount of \$14,047,947.

DULY ADOPTED at a duly noticed public hearing this 7th day of September, 2016.


