Actuarial Valuation Authorization

Our records indicate that an actuarial valuation was last completed for the plan year 10/1/2015.

Chapters 175, 185 & 112 of the Florida Statutes require that an actuarial valuation be performed once every three years. The Administrator recommends that a valuation be performed once every two years in accordance with the following GASB rule:

Governmental Accounting Standards Board Statement (GASB) No. 27, paragraph 9, states, "For financial reporting purposes, an actuarial evaluation should be performed at least <u>biennially</u> in accordance with this paragraph and paragraph 10. The actuarial valuation date should be the same date each year (biennium). However, a new valuation should be performed if significant changes have occurred since the previous valuation in benefit provisions, the size or composition of the population covered by the plan, or other factors that affect the results of the valuation."

An actuarial valuation should be performed every year if significant plan amendments or changes in census have occurred.
