Fire / EMS Report:

This month the training division would like to thank Manatee County Parks. We were able to utilize the pool at the South County YMCA for Part I of our annual water rescue practicals. We were taught techniques on drowning victims, how to remove them from the water, as well as how to approach a panicked swimmer. Part II will be scheduled in September with the sunken car and victim removal. This month we also hosted a 2 hour In-Service by Saleh Freedom. This course focused on the sex trafficking of children and drug addiction issues. All crews were cycled through the admin for this class. The remaining personnel also attended a 3 hour Confined Space practical at Tropicana. These drills were completed in June; however 3 companies were unable to attend due to high call volumes. Group Fitness this month centered on stretching and proper lifting techniques to prep for the Chiropractor visit next month. Finally this month crews continued through Target Solutions to obtain CEU credit for EMS & Fire Licensure.

Special Operations Report:

The month of July was a return of an annual class "Chlorine emergencies and response". The eight-hour course is designed to give the individual the knowledge of handling chlorine in both the industrial and emergency settings. Participants will receive information about the properties of chlorine, containers storing chlorine, common chlorine practices and emergency response procedures should chlorine leak into the atmosphere. Participants will also have an opportunity to apply emergency response kits to simulated chlorine containers in a "hands on" environment. This was another regional class for the Local Emergency Planning Committee with 34 students from a four-county area.

- Captain Thayer proctored aerial testing and competencies testing with personnel.
- Captain Thayer has started working with the Manatee County Fire Coordinators, and will be taking over as SMFR team member.
- Captain Thayer is work with IAFF to bring in the "Solar Panels Fire" class in September.
- Captain Thayer proctored promotional written testing.
- Captain Thayer & Captain Bloski completed Haz-Mat team assessments.
