#### RESOLUTION 2013 – 04 2013 PROPOSED MILLAGE RATE SOUTHERN MANATEE FIRE & RESCUE DISTRICT

A RESOLUTION OF THE SOUTHERN MANATEE FIRE & RESCUE DISTRICT OF MANATEE COUNTY, FLORIDA, ADOPTING THE PROPOSED LEVY OF AD VALOREM TAXES FOR THE SOUTHERN MANATEE FIRE & RESCUE DISTRICT FOR FISCAL YEAR 2013/2014, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of Fire Commissioners for the Southern Manatee Fire & Rescue District of Manatee County, Florida, on September 12, 2013, adopted Fiscal Year 2013/2014 proposed millage rates following a public hearing as required by Florida Statutes 200.065; and

WHEREAS, the Board of Fire Commissioners for the Southern Manatee Fire & Rescue District of Manatee County, Florida, held a public hearing as required by Florida Statutes 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Manatee County has been certified by the County Property Appraiser to the Board of Fire Commissioners for the Southern Manatee Fire & Rescue District as \$3,440,852,543.

NOW THEREFORE BE IT RESOLVED by the Board of Fire Commissioners of the Southern Manatee Fire & Rescue District of Manatee County, Florida, that:

- 1. The above recitals are true and correct and are incorporated fully herein by reference.
- 2. The Fiscal Year 2013/2014 operating millage rate for the Southern Manatee Fire & Rescue District is 1.0193 mills which is equal to the rolled-back rate.
- 3. This resolution shall take effect immediately upon its adoption.
