**WHEREAS**, the Board of Fire Commissioners for the **Southern Manatee Fire & Rescue District** of Manatee County, Florida, on September 12, 2013, held a public hearing as required by Florida Statutes 200.065; and

**WHEREAS**, the Board of Fire Commissioners for the **Southern Manatee Fire & Rescue District** of Manatee County, Florida, set forth the appropriations and revenue estimate for the Budget for Fiscal Year 2013/2014 in the amount of \$11,830,304.76.

**DULY ADOPTED** at a proposed public hearing this 12<sup>th</sup> day of September, 2013.



The purpose of the hearing is hear testimony and adopt the 2013 Proposed Millage Rate.

Following the 2013 Proposed Millage Rate Hearing, the Board of Fire Commissioners of the Southern Manatee Fire & Rescue District will hold a second public hearing. The purpose of the hearing is to hear testimony and adopt the proposed budget for the 2013/14 fiscal year.
