A RESOLUTION OF THE SOUTHERN MANATEE FIRE & RESCUE DISTRICT OF MANATEE COUNTY, FLORIDA, ADOPTING THE PROPOSED LEVY OF AD VALOREM TAXES FOR THE SOUTHERN MANATEE FIRE & RESCUE DISTRICT FOR FISCAL YEAR 2014/2015, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of Fire Commissioners for the Southern Manatee Fire & Rescue District of Manatee County, Florida, on September 10, 2014, adopted Fiscal Year 2014/2015 proposed millage rates following a public hearing as required by Florida Statutes 200.065; and

WHEREAS, the Board of Fire Commissioners for the Southern Manatee Fire & Rescue District of Manatee County, Florida, held a public hearing as required by Florida Statutes 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Manatee County has been certified by the County Property Appraiser to the Board of Fire Commissioners for the **Southern Manatee Fire & Rescue District** as \$3,674,474,297.

NOW THEREFORE BE IT RESOLVED by the Board of Fire Commissioners of the Southern Manatee Fire & Rescue District of Manatee County, Florida, that:

- 1. The above recitals are true and correct and are incorporated fully herein by reference.
- 2. The Fiscal Year 2014/2015 operating millage rate for the Southern Manatee Fire & Rescue District is 1.2061 mills which is higher than the rolled-back rate of 0.9652 mills by 24.96%.
- 3. This resolution shall take effect immediately upon its adoption.


