**A RESOLUTION OF THE SOUTHERN MANATEE FIRE & RESCUE DISTRICT OF MANATEE COUNTY, FLORIDA, ADOPTING THE FINAL BUDGET FOR THE FISCAL YEAR 2014/2015, PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Board of Fire Commissioners for the **Southern Manatee Fire & Rescue District** of Manatee County, Florida, on September 10, 2014, conducted a duly noticed public hearing to consider the adoption of a final Budget for Fiscal Year 2014/2015 as required by Florida Statutes 200.065; and

**WHEREAS**, the Board of Fire Commissioners for the **Southern Manatee Fire & Rescue District** of Manatee County, Florida, set forth the appropriations and revenue estimate for the final Budget for Fiscal Year 2014/2015 in the amount of \$12,646,318.49.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Fire Commissioners of the **Southern Manatee Fire & Rescue District** of Manatee County, Florida, that:

1. The above recitals are true and correct and are incorporated fully herein by reference.
2. The Fiscal Year 2014/2015 final Budget is hereby adopted.
3. This resolution shall take effect immediately upon its adoption.

**DULY ADOPTED** at a duly noticed public hearing this 18<sup>th</sup> day of September, 2014.



## PUBLIC NOTICE 2014 FIRE TAX APPEALS HEARING AND 2014 MILLAGE RATE HEARING AND 2014/15 FISCAL YEAR BUDGET HEARING SOUTHERN MANATEE FIRE & RESCUE DISTRICT

Notice is hereby given that on Thursday, September 18, 2014, at 6:00 p.m. or as soon thereafter as the matter may be heard at the Southern Manatee Administrative Offices located at 2451 Trillmate Drive, Sarasota, FL 34243, the Board of Fire Commissioners of the Southern Manatee Fire & Rescue District will hold a public hearing. The purpose of the hearing is to hear appeals from any property owner in the district with respect to the method of calculation and/or the amount of the 2014 fire assessment levied against any parcel of property located within the district, such special assessments shall be a lien upon the land so assessed until said assessments have been paid.

Following the 2014 Fire Tax Appeals Hearing, the Board of Fire Commissioners of the Southern Manatee Fire & Rescue District will hold a second public hearing. The purpose of the hearing is to hear testimony and adopt the 2014 Millage Rate.

Following the 2014 Millage Rate Hearing, the Board of Fire Commissioners of the Southern Manatee Fire & Rescue District will hold a third public hearing. The purpose of the hearing is to hear testimony and adopt the budget for the 2014/15 fiscal year.

Interested parties are encouraged to attend either in person or by agent or submit their appeal in writing prior to the date of the public hearing.

If any person desires to appeal any decision of the Fire District Board of Commissioners or of any other board of commission of the District, that person will need to ensure that a verbatim record of the proceedings is made which record includes the testimony and evidence upon which the appeal is to be based. (F.S. 286.0105).
