**WHEREAS**, the Board of Fire Commissioners for the **Southern Manatee Fire & Rescue District** of Manatee County, Florida, set forth the appropriations and revenue estimate for the tentative budget for Fiscal Year 2016 - 2017 in the amount of \$14,047,947.



3. This resolution shall take effect immediately upon its adoption.


