WHEREAS, the Board of Fire Commissioners for the **Southern Manatee Fire & Rescue District** of Manatee County, Florida, set forth the appropriations and revenue estimate for the budget for Fiscal Year 2020 - 2021 in the amount of \$18,777,675.41.


1. The above recitals are true and correct and are incorporated fully herein by reference.

3. This resolution shall take effect immediately upon its adoption.





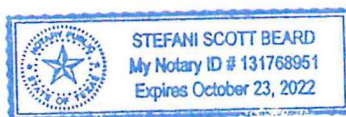
