

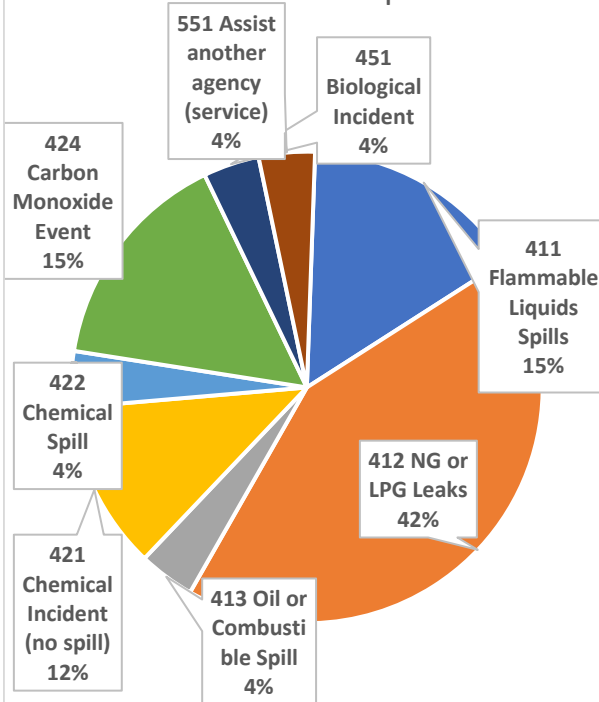

March 2022 SMFR Average Response Time (Hazmat) 5.4 Minutes

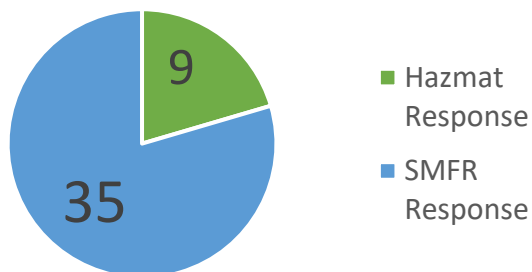

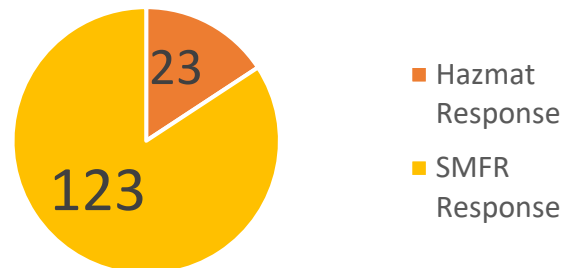
